

Action Plan: June 2017

Following the commissioning of a Landscape & Transport Infrastructure Strategy (LTIS) from Cornwall Environmental Consultants and a public consultation event on the 20th October 2016, the Porthcurno Coastal Community Team have identified the following series of actions.

| B1.1 | Apply for a revised Traffic Regulation Order (TRO) to cover the following: a) extend double yellow lines to the northern edge of the village – suggested 8am to 9pm, 1st March to 31st October b) amend the seasonality of the parking restrictions on the Valley Road to 8am to 9pm, 1st March to 31st October c) install priority signage on the pinch points outside the old Post Office and at the bottom of Mansell's Hill d) install a white line down the middle of the road on the bend on Maunsell's Hill e) consider reduction of speed limit through the Valley f) installation of road markings outside the Beach Café as a pseudo crossing g) amendments to the traffic flow into the car parks. h) Consideration of pseudo footpaths marked on the roadways from the Old Post Office to Old Cable Lane and on Mansell's Hill. | £4,800 cost for TRO which CCT would meet.
